## Dear Sheriff Mendrick:

The Kennedy Forum Illinois is a nonprofit organization under the umbrella of The Kennedy Forum whose mission is to eliminate stigma against people with mental health and substance use disorders (MH/SUDs) and increase access to evidence-based treatment for all who need it. It is in the spirit of this mission that we urge you to personally ensure Ms. Christine Finnigan is able to access her prescribed medication-assisted treatment (MAT) for Opioid Use Disorder (OUD) while in the custody of the DuPage County Sheriff.

Jails and prisons are constitutionally and morally obligated to provide inmates with adequate medical care<sup>i</sup> – including care for MH/SUDs. If an inmate was ill with cancer or diabetes, they would be guaranteed access to medically necessary treatment. Inmates with substance use disorders are no different. They have the same right to the care necessary to treat their medical condition and remain on a path to long-term recovery. OUD is life-threatening medical condition, for which physician prescribed medication is medically necessary. Forcing inmates with OUD off of MAT is dangerous and unnecessarily puts their lives at risk. In fact, in late 2018, a federal judge affirmed the right to MAT for an individual with OUD under the federal American with Disabilities Act and the Eighth Amendment.<sup>ii</sup>

Our state – and our country – was in the midst of a mental health and addiction crisis before COVID even hit. And in 2020, Illinois saw a record number of opioid overdose deaths, including an increase of 17% in DuPage County. MAT is the gold-standard for treatment of OUD and research has shown that these medications are proven to save lives. For example, the Rhode Island Department of Corrections has successfully implemented an effective MAT program that has drastically reduced overdose deaths amongst recently released inmates and "changed [the] lives" of inmates who have graduated from the program.

You have recognized that jails should seize every opportunity to help people with MH/SUDs get on a path to recovery. Viii If you truly believe this, then it is imperative to follow the science and provide inmates access to the treatment that is most effective.

The DuPage County Sheriff can be a national leader in this regard by guaranteeing that inmates with OUD have access to MAT while in its custody. We call upon you to allow Ms. Finnigan to continue her MAT and make progress on her path to recovery. Additionally, we urge you to ensure that *all* inmates with MH/SUDs in the custody of the DuPage County Correctional Facility have access to the care they need and deserve.
